The Ordinance on concession approvals in a protected area, adopted on 3 February 2021 (NN 9/2021), defines that **concession approvals can be issued on request - by filling out the form or on the basis of a public invitation.** Issued concession approvals are submitted to the Croatian Ministry of Economy and Sustainable Development for insight into the implementation of economic activities such as bird watching tours, excursions, and educational programs, photography and filming for commercial purposes, rental of equipment for recreation and sports, rental of accommodation, sale of family farm products, beekeeping, livestock, and the like.
